AN ORDINANCE OF THE VILLAGE OF HIGHLAND PARK, FLORIDA, PROVIDING FOR FORMAL RECOGNITION OF LAKE AMORET NATURE PARK AND THE ESTABLISHMENT OF ALTAVISTA PARK; PROVIDING FOR CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

This ordinance identifies with specificity those lands which comprise 'Lake Amoret Nature Park' and establishes 'Altavista Park.' It is anticipated that prior to the ordinance's adoption the Village Commission of the Village of Highland Park will determine that it is in the best interests of the health, safety, and welfare of the public to recognize and dedicate the lands identified within the ordinance as public park lands.
